Subject: Fully Online Degree Program/Student Coding in CUNYfirst


This process memorandum is being issued to inform you that the Committee on Fiscal Affairs recommended, and the University Board of Trustees passed, a revised Tuition Schedule to include a Non-Resident Online Degree Program Tuition Category for Senior Colleges and Professional Schools and an Online Infrastructure Fee for all Fully Online Programs at all colleges, effective Spring 2023.

The Board of Trustees of The City University of New York (the "Board of Trustees") adopted a revised schedule of student tuition that includes a tuition rate for fully online degree programs for non-resident students at 1.2 times the resident tuition rate for online undergraduate and graduate degree programs at the University's senior colleges and graduate and professional schools. The fully online non-resident undergraduate tuition rate is calculated by equating the full-time resident rate into a per credit rate and increasing that rate by 20%.


An Online Infrastructure Fee of \$75 per semester was also authorized for all fully online degree programs at all colleges and programs University-wide.

As shown below, coding has been configured in CUNYfirst to identify and track fully online programs and students enrolled in those programs. The coding enables assessment of the tuition rate and infrastructure fee. These are now being assessed. Please ensure that your campus tuition and fees webpage includes this information.

- ONLN Student Group Configured for all schools:
  - Used for Immunization Exclusion
  - Used for Reserve Capacity Enrollment requirement configuration to reserve seats for fully online students.
  - Request access via your local ASL and helpdesk.




- Subplan Configured for Majors that are approved by NYSED as Distance Education and designated by the campus as Fully Online.
  - Used for Tuition Calculation and Fee Calculation, per board policy
  - Used for Reporting and Tracking
  - Used for Online Admission Application


